

The Atlanta Sister Cities Commission

The Atlanta Sister Cities Commission (ASCC) was chartered by the City of Atlanta and codified in Atlanta City Ordinance No. 1979-71. The organization is managed by a Chair, elected by the ASCC membership. The appointee must be ratified by a majority of the Atlanta City Council. Teri Simmons was elected as Chair, and Wilma Kruger as Vice Chair, in 2008.

The full 'board' of the Commission comprises the Chair, three additional Mayoral appointees and two members appointed by the City Council. In addition, the chairpersons of each Sister City Committee, or their designee, serve on the Commission.

The Mayor's appointed members in 2008 were Cedric Suzman, Ph.D, and Samuel Bacote.

Elections are held annually to select a Vice Chair, a Secretary and a Treasurer. Each elected officer serves a one-year term. Elected officials of the Commission are restricted to two consecutive terms in office.

Staff

The Commission is supported by the staff of the International Affairs Division of the Mayor's Office. The staff participates in monthly and special meetings, helps shape the Commission's policy and acts as liaison with the Mayor. In 2008, Claire McLeveighn, director of External Affairs and International Relations, and David Constant, International Affairs Manager, played a vital role as coordinators for the Mayor's Office. Following Claire's reappointment to Marketing and Business Development at Hartsfield-Jackson Atlanta International Airport, Greg Pridgeon, Chief of Staff, Atlanta City Hall, has supported the Commission.

ASCC maintains a web site with press releases, annual reports and information on each of the sister cities.



Economic Development Sub-Committee

❖ The Atlanta Sister Cities Commission Economic Development Sub-Committee spent all of 2007 in planing for its second Economic Development Partnership Forum held on March 12 through 14, 2008. Titled 'Greener Cities: Public Transit and Green Space Policies' the event was aimed at facilitating the exchange of economic development practices and increasing awareness of economic conditions among Atlanta's sister cities.



- ❖ The forum, co-hosted by the City of Atlanta, and CIFAL Atlanta was designed to broaden participants' knowledge of the benefits of environmental improvements in land use and transportation policies and to enable delegates to return to their respective countries with a method for managing the opportunities and challenges presented by the sustainable planning of cities.
- Participating delegates included representatives from sister cities Nürnberg, Germany; Montego Bay, Jamaica; Ra'anana, Israel; Salcedo, Dominican Republic; and Taipei, Taiwan and representatives from Ningbo, China; Porto Alegre, Brazil; Ahmedabad, India; and Kingston, Jamaica.

❖ The conference was coordinated in cooperation with CIFAL Atlanta, the only North American affiliate of the United Nations Institute for Training and Research (UNITAR), and with the support of the Atlanta City Council's Advisory Committee on International Relations (ACIR), the Metro Atlanta Chamber of Commerce, with support from the Atlanta Beltline, Inc. and the BeltLine Partnership; and the Metropolitan Atlanta Rapid Transit Authority.



- The forum highlighted the benefits of public transit and green space programs worldwide and helped communicate the City of Atlanta's environmental initiatives, such as Sustainable Atlanta and the Beltine project, which the delegates had the option of touring.
- ❖ A Welcome Dinner in the Atrium of Atlanta City Hall enabled delegates and their Atlanta hosts to meet in a festive environment. Atlanta Mayor Shirley Franklin welcomed all the guests and recognized sister city anniversaries and individual leaders for their contribution to the sister city program.
- ❖ With a year in planning and a target of \$50,000 in sponsorship, the Atlanta Economic Development Partnership Forum shows how the Atlanta Sister Cities Commission is supporting the economic development goals of Atlanta as well as its partner cities. Participants had the opportunity to learn from the experiences of other partner cities during the conference, and to meet with host sister city committee members and hold other social and business-related meetings before and after the event.

- This year the Ancient Olympia Committee has been involved in many activities.
- ❖ In February, Dr. Platon Mavromoustakos, Professor of Theater Studies, University of Athens gave a lecture about Ancient Greek Comedy on the Modern Greek Stage at the Michael C. Carlos Museum Reception Hall. After, the committee met with Dr. Mavromoustakos to discuss relations between the University of Athens and the Universities here in Atlanta.
- * All throughout March, the committee was proud to be one of the sponsors of the Greek film festival program Passport To Greek Film at the High Museum Of Art Atlanta. While in Greece last summer, Co-Chairman, Mrs. Maria Mandekos Sharp, met with Greek Officials and she was able to secure this Greek Film Festival to be presented at the High Museum of Arts here in Atlanta.
- ❖ March 25th, Greek Independence Day was celebrated at the Carlos Community Center with the Greek Community here in Atlanta, GA with the Consul of Greece, Mr. Lambros Kakissis.
- In June, the committee was honored to host, Ms. Anna Diamantopoulou. She is a Member of the Greek Parliament and former member of the EU Commission. She also had a meeting with Mayor Franklin during her visit here. Also, in June, the committee along with Consul Kakissis, had the opportunity to have a meeting with Ambassador Angelos Pangratis, Deputy Head of the EU Commission in Washington. It was a very informative and productive meeting.

- Also in June, the High Museum of Art and the Consulate of Greece in Atlanta sponsored a lecture "Building the NewAcropolis Museum" by .Dr. Dimitrios Pandermalis, President of the New Acropolis Museum in Athens Greece. The Committee had the pleasure of hosting Dr. Pandermalis as well during his visit here in Atlanta.
- While in Greece, in July, Chairman Margo Alexander and Co-Chairman, Mrs. Maria Mandekos Sharp, met with Greek Officials about an exchange program for students in the area of Higher Education as well as Greek Folk Dance and Customs. Also, Chairman, Margo Alexander was a guest of Dr. Dimitrios Pandermalis, President of the New Acropolis Museum in Athens Greece for a special viewing of the new Museum. Before returning home, Chairman Margo Alexander was also able to visit Ancient Olympia.
- In September, the Committee hosted a reception in honor of Consul Lambros Kakissis. Consul Kakissis ended his term here in Atlanta and returned to Greece.
- ♦ In November, the Ancient Olympic Committee members met the new consul, Vassilis Goulousis to welcome him to Atlanta and to let him know of our relations between the city of Atlanta and Ancient Olympia and all of Greece.






Atlanta - Fukuoka Sister City Committee

- ♦ In January, a group of 30 members including children gathered at the Leedy's beautiful home in Acworth for the New Year's kick off. All enjoyed the delicious Japanese food Mrs. Leedy prepared. We also enjoyed visiting the Japanese Room Mr. Leedy built for his wife, complete with sliding paper screen doors (Shoji), tatami mat floor and traditional Japanese alcove decorated with a floral arrangement and Koto musical instrument.
- In February, we partnered with Japan America Society of Georgia to assist in selecting six junior ambassadors (10 & 11 year-olds) from Atlanta area to participate in the Asian Pacific Children's Conference (APCC), 2-week event to be held annually in July in Fukuoka.
- In March, we welcomed two Fukuoka high school students who were winners of the speech contest sponsored by the City of Fukuoka. Their trip was funded by Japan Airlines and Coca Cola Japan/Southwest. The students enjoyed attending North Atlanta High School and their home stay with one of its faculty members. The Fukuoka group members served as their guides and drivers to visit Atlanta sights such as Coca Cola Museum, CNN and Stone Mountain. We enjoyed a welcome dinner reception with the visiting students and their host family at Hashiguchi Jr. restaurant in Buckhead.
- In June, while visiting their families in Fukuoka, Keiko Scott and Sue Renfroe called on the Fukuoka City officials to discuss our future activities. We assured them our cooperation to support the student exchange program.
- In September, twenty members of our group met at Hashiguchi restaurant on Windy Hill Rd., for a dinner meeting to socialize and discuss our participation in JapanFest.
- On the last weekend of September, we participated in JapanFest at Gwinnett Center for two days. JapanFest had fewer attendees this year due to the shortage/higher price of gasoline and economy situation. The Fukuoka Sister City group sent us many unique Fukuoka products to sell at affordable price to festival attendees. We use the proceeds of these sale to help fund our activities. Many people were happy to obtain famous Hakata weave products and Hakata clay dolls. We also offered pamphlets to introduce Fukuoka. Several past Junior Ambassadors to Fukuoka (APCC) also volunteered to showcase their Fukuoka experience using their displays and talking to the people interested in this all-expense-paid invitational program. JapanFest was an opportune time to advertise the Atlanta-Fukuoka Sister Cities relationship not only to local residents but also to Japanese nationals residing in Georgia.

- In December, the Fukuoka Group met for dinner at Umezono restaurant to review the activities and plan for 2009. We discussed the possibility of becoming a sub-committee of Japan America Society of Georgia for strategic planning and expansion of our activities.
- ♦ We had applied for and received the education fund from ACIR. Fukuoka City has sent students to Atlanta each year, but Atlanta hasn't sent any students for three and half years due to lack of funds and program sponsors/coordinators. Our application was chosen for this fund and we won a check of \$3,420. We immediately made plans using that fund to select two students to visit Fukuoka in early part of 2009. Dr. Douglas Frutiger of North Atlanta High School International Studies would assist in selecting qualified students to represent Atlanta for the Atlanta-Fukuoka exchange program.







Atlanta-Lagos Sister City Committee

- 2008 continued to be a project driven year centered around key developmental axes enunciated in the Millennium Development Goals (MDGs) and contained in Nigerian President Umaru Musa Yar'Adua 7 Point Development agenda. The Committee tackled several projects within the education, health and water resources sectors:
- In the field of education, the Committee under the leadership of its Chair, Professor Augustine O. Esogbue, teamed with the National Society of Black Engineers (NSBE), a U.S. based technological organization to hold an international leadership summit (ILS) in Nigeria. The summit's operational base was Lagos, Nigeria. The delegation met with the Rector (President) of Yaba College of Technology (YabaTech) Nigeria's oldest engineering school, for permission to set up a chapter of NSBE on his campus as a vehicle for educating a new breed of well educated engineers who are socially relevant and who positively impact their communities. It would also enable NSBE to share rare technological resources with their chapters in Nigeria including YabaTech. The team also took the occasion to pay a courtesy visit to the U.S. Ambassador to Nigeria and discuss ways to facilitate the issuance of U.S. visas to Nigerians including members of the Lagos Atlanta Sister City Committee to visit the U.S. to participate in our many Sister Cities programs. The committee resurrected its Book for Lagos Drive. Discussions of ways of aiding the actualization of the project continued with former Senator and now Lagos State Commissioner, Tokunbo Afikuyomi and Federal House Member from Lagos, Honorable Taylor. Several of our members were active in the educational area. Various members of our Committee were active in promoting education in and around Lagos. Member Dr. Eugenia Olusola George, President of the Nigerian Women Association of Georgia, continued her work in helping her mother set up a school in Lagos Island while another member, Chief Alani Ogunlade continued his work to set up a school in his hometown outside Lagos State. - In the area of scientific, technological and manpower development which especially targets the involvement of Nigeria's Diaspora in national development, a number of members of the Committee took part in various conferences and meetings in Nigeria throughout the year. During the annual Diaspora Day in Nigeria celebration, Professor Esogbue was an invited panelist and key note presenter on the Role of the Nigeria's Diaspora in attaining the goals of President Yar'Adua's 7 Point Developmental Agenda in a Science and Technology conference held in Tinapa, Calabar in July, 2008.
- The hallmark of the year's project activities is the Committee's successful proposal with the Sister Cities International (SCI) Safe Drinking Water Initiative (SDWI) to fund a project geared towards providing safe drinking water for its member cities mostly in developing countries. Lagos is one of the 3 cities in Africa that won funding for this project. This is the first such award recorded by ASCC. Several visits were paid by the Committee Chair to Lagos and Abuja to initiate discussions with our local counterpart and discuss strategies to make the project successful. An official contract has been signed between the Atlanta Sister Cities Commission on behalf of the Lagos Committee and Sister Cities International for distribution of PUR (Purifier of Water) sachets produced by Procter and Gamble and distributed in Nigeria by the Society for Health (SFH). When the pilot project is completed in 2009, it is expected that over 950 families in Lagos Island would have been served with rare and scarce safe drinking water which promotes good health and minimizes exposure of the citizens to various water borne diseases which are prevalent in Africa.

Atlanta - Montego Bay Sister Cities Committee

- ♦ The Atlanta-Montego Bay Sister Cities Committee (the "Committee") has been in existence since 1972. The following committees have been designed to maximize the effectiveness of the relationship and to play upon the strengths of each city. The most active sub-committees are as follows:
- · Cultural Affairs
- Education
- Fundraising
- Health and Human Services

2008 Activities

- * Cultural Affairs: The Committee played an active role with other Atlanta based Jamaican organizations in planning the celebration of Jamaica's 46th independence anniversary. The Committee also held its annual gospel brunch at Atlanta City Hall featuring aspects of Jamaican Gospel music.
- * Education: In keeping with our mission to assist in educating students in Montego Bay, the Committee provided financial support to a student attending Montego Bay High School. In our annual mission to Montego Bay, we delivered books and school supplies to several Basic School students as part of our committee's effort to assist in the growth and development of young students.
- Physicians, nurses and patients participating in the Montego Bay fifteenth annual health mission.

- * Fund Raising: The Committee held its eighth annual fund raising golf charity tournament at the Bobby Jones Golf Course in Atlanta. Additionally, our annual fund raising ball was held in September. The proceeds from these events were used in conducting our Health Mission and assisted in providing needed medicines to the underserved patients seen in Montego Bay.
- ♦ Health and Human Services: The fifteenth annual medical mission to Montego Bay was undertaken in October, 2008. Our team comprising 34 physicians, nurses and other medical professionals provided needed medical care to over 1,800 patients during the 3 ½ days of the mission. The team also donated a significant quantity of medicine and medical supplies to these patients. As is our custom, a group of our physicians attended to the HIV/AIDS patients organized by the Montego Bay Chapter of the Jamaica Aids Support.
- Other Events: The Committee participated in the Public Transit and Green Space Policies Forum hosted by the Sister Cities Commission in March. Montego Bay's Mayor His Worship Charles Sinclair led a delegation of four members from Montego Bay to the conference. His visit also included an official call on Mayor Franklin.
- In October a delegation of sister cities members visited Atlanta to engage in joint Sister Cities planning for the upcoming year. While here, the delegation met with Councilman Jim Maddox, Ambassador Andrew Young and the Executive Director of the Atlanta Housing Authority, Ms Rene Glover.
- Other activities in which our Committee engaged were the annual Mayor's Christmas treat for the Children of Montego Bay. We contributed toys and financial assistance to that effort. Further, our Committee financed a Christmas luncheon for the Jamaica Aids Support Chapter in Montego Bay. We also funded a luncheon for the patients of the psychiatric ward at the Montego Bay Regional Hospital.

Atlanta - Nürnberg Sister City Committee

- ❖ 2008 marked the 10-year anniversary of twinning between the great cities of Atlanta and Nürnberg. The anniversary celebration, affectionately known as Nürnberg Days, was full of activities centered around social, cultural, and educational exchanges and the impact these exchanges have on the economic development of both cities. Dr. Ulrich Maly, Lord Mayor of Nürnberg, led a delegation of approximately fifty government, business, academic, and cultural leaders to Atlanta for a joint commemoration of ten years of a mutually beneficial partnership.
- ❖ Atlanta Mayor Shirley Franklin along with Nürnberg's Lord Mayor Ulrich Maly officially kicked off the 10-year anniversary celebration with a wreath laying ceremony at the crypt of late civil rights leaders Rev. Dr. Martin Luther King, Jr, and Mrs. Coretta Scott King. The wreath, adorned in an array of red and white flowers, beautifully represented the colors of Nürnberg. The ceremony was also attended by King Center President Isaac Farris, nephew of Dr.

❖ Following the wreath laying ceremony, the Atlanta-Nürnberg Sister City Committee hosted a gala dinner in the City Hall Atrium for over 250 government officials, members of the business community, international enthusiast, and academicians. Event guests dined on a traditional southern supper while experiencing the visual landscape of local mixed-media art by local artist Najee Dorsey, and enjoying the soulful sounds of Kathleen Bertrand. Ms. Bertrand traveled to Nürnberg with her trio five years ago to celebrate our five-year anniversary in 2004. The gala event was made possible through partnerships within the respective cities and the generosity of Arnall Golden Gregory, NürnbergMesse, Kuehne+Nagel, Nürmont, Rödl & Partner, the Consulate General of the Federal Republic of Germany, the Metro Atlanta Chamber of Commerce, Reece and Associates, and Porsche Cars North America.

- The anniversary celebration and delegation visit coincided with the 60th anniversary of the Universal Declaration of Human Rights, issued by the United Nations General Assembly of 1948. Both Atlanta and Nürnberg are historic cities in the story of human rights; therefore, Nürnberg Days included a joint ceremony and program at Sisters Chapel on the campus of Spelman College. The mayors of the two cities elaborated on their cities' histories and the steps currently taken to protect human rights and civil liberties in the present and for the future. Just as the world over knows Atlanta as the "City of Civil Rights," Nürnberg is also making great strides to become equally noted as the "City of Human Rights." Nürnberg has created a huge documentation center to capture the atrocities of the Nazi era which will serve as a reminder of the city's sordid past and where its people never want to return. Likewise, the people of Atlanta are currently developing a Center for Civil and Human Rights as a tool for recognizing the progress our country has made in race relations and equality for all.
- Dr. Ulrich Maly, Lord Mayor of Nürnberg also utilized his first visit to Atlanta to officially open the North American Offices of NürnbergMesse, one of the world's largest exhibition companies. This inaugural visit was highlighted by a series of high-level meetings, galas, historic tours, and business meetings.

- During this year's festivities, Teri Simmons, chair of the Atlanta Sister Cities Commission, and past chair of the Atlanta-Nürnberg Committee, received the prestigious Federal Republic of Germany Friendship Award. Consul General Dr. Lutz Görgens presented Ms. Simmons the award on behalf of the people of Germany for her decade-long leadership role in the sister city relationship between Atlanta and Nürnberg. A founding member of this twinning, Ms. Simmons has dedicated countless hours to this partnership, through business, culture, and economic exchanges.
- * Additionally, native Atlantan Rod Brown, with the assistance of NAKO (The Nürnberg-Atlanta Committee), visited Germany to oversee operations of Atlanta's successful participation in the international segment of the 2008 Christkindlmarkt. Brown dedicated several pre-travel hours to source and select US vendors and acquire native crafts and consumables representing Atlanta and the United States as a whole. Among the popular items for German consumers were US Flags; red, white, and blue Christmas ornaments; Obama paraphernalia and all manner of US snacks and treats.
- ❖ So marks another year in successful partnership between the people of Atlanta and our friends of Nürnberg. The Atlanta-Nürnberg Sister City Committee is already busy at work developing programs and activities to continue and further committee goals. There is mutual excitement and anticipation for things to come on both sides of the pond!

2008 Highlights

- * December On December 16, Mr. Michael Tyler, Chair of the Cultural Committee represented the Organization at the Latino Leadership Award Ceremony.






Atlanta - Ra'anana Sister City Committee

- ❖ For the Atlanta Ra'anana Sister City Committee (ARSCC), 2008 was a year of maintaining ongoing programs and organizing a variety of joint projects. The major undertaking was Ra'anana's attendance at the ASCC's March 12 − 14 Greenspace and Public Transit Conference. The ARSCC supported the visits of Mrs. Oshra Koren, a City Council member and Chairperson of Ra'anana's International Relations Committee and Ms. Lia Rudnicki, Deputy City Engineer. Mrs. Rudnicki was a conference presenter and described the renovation of Ahuza St., Ra'anana's main thoroughfare into a grand pedestrian boulevard.
- Ra'anana, with a population of around 80,000, is located about fifteen miles north of Tel Aviv. With many immigrants from the U.S., Canada, U.K., Australia and South Africa, Ra'anana is often referred to as the center of 'Anglo Israel'. The 'garden city' of Israel is recognized for its high quality of life and commitment to physical, economic and cultural development through global linkages such as the sister city partnership with Atlanta.

Ra'anana was settled in 1922 by American Zionists from New York City - the below picture shows Ahuza Street in 1925.

- Mr.Tom Glaser, President, American Israel Chamber of Commerce, Southeast Division (AICCSE), says that the main reason for Ra'anana's regular inclusion in Chamber missions to Israel is that the city is simply a good place to do business. The AICCSE, during 2008, organized two activities with Ra'anana companies:
- ❖ Co-sponsored with Ra'anana-based Amdocs a one-day Innovation Exchange in Atlanta on April 29th for AT & T that introduced 12 Israeli start ups with cutting edge mobile technologies. Specific areas included Convergence, Mobile Personalization, Web 2.0 and Customer Experience Measurement and Optimization.
- ❖ December Business Mission delegation held a seminar in Ra'anana at Yad LaBanim municipal center to introduce over 20 local Israeli companies to AICC services. Special track sessions were conducted in Energy, Water and Medical Devices.
- ❖ During 2007, the ARSCC's electronic pen pal program (Gan Aleph) assisted the Greenfield Hebrew Academy (GHA) in a joint project with Ra'anana's Gan Tziporen kindergarten classes. During 2008, the ARSCC helped expand the program to include GHA's third grade; Judy Nickeson (GHA teacher) is involving her students in exchanging email letters to Bartov School peers in Ra'anana.








Atlanta - Rio de Janeiro Sister City Committee

'Government officials and business leaders joined Consul General Adalnio Senna Ganem for a ribbon-cutting ceremony and champagne toast at the consulate's eighth-floor offices in the One Alliance Center building in Buckhead.



"We had a long process opening up the consulate, but we are here, and we are here to stay," Mr. Ganem said.

Today's opening makes this consulate the first established since the government launched a concerted effort to place diplomatic representation near its large communities abroad.'



Atlanta - Rio de Janeiro Sister Cities Foundation

- ❖ The Atlanta-Rio de Janeiro Sister Cities Foundation (ARJSCF) is a nonprofit entity building global co-operations, enhancing educational opportunities, promoting cultural understanding, and stimulating economic development in the United States and Brazil.
- * ARJSCF was founded in 2007 in Atlanta, Georgia as the funding arm for The Atlanta-Rio de Janeiro Sister Cities Committee. In 2008 the Brazilian federal government recognized the Foundation as a legal entity, making it the first of Atlanta's 19 Sister City groups approved to operate in a foreign country.
- ARJSCF had the following opportunities, this past year.
 - ARJSCF became a legal entity in Brazil (December 2008)
 - The foundation officers met with the Brazil Ambassador, on his visit to Atlanta (November 2008)
 - The foundation office opened in downtown Rio de Janeiro, Brazil (January 2009)

Dedication Of Park Atlanta In The Atlanta's Sister City Of Salcedo, Dominican Republic

- Parque Atlanta was a project created to honor the three Dominican heroines that were brutally assassinated by the Trujillo dictatorship in the year 1960. The park has a giant butterflyshaped amphitheater symbolizing the three heroines who fought for freedom, justice, human and women's rights in the Dominican Republic.
- The park project initiated in 2001 with the collaboration of various community and business leaders, civic and government organizations from both sister cities, Atlanta and Salcedo. It receiived significant contributions from Williams-Russell and Johnson Engineering Co., Guerra-Stoll Barker Architects, and Atlanta City Hall. In Salcedo, there were significant contributions from Mena-Pantaleon Engineering Co., the Dominican Justice Supreme Court, and the Salcedo City Hall. Since the beginning of the project, there was a strong support from the former Vice-President of the Dominican Republic and current Secretary of State of Environment and Natural Resources, Dr. Jaime David Fernández Mirabal and his mother, Ms. Bélgica -Dedé- Mirabal.
- Pargue Atlanta was dedicated in October, 2008 with music concerts played by the Musical Band of the Arm Forces of the Dominican Republic and the Orchestra of the Dominican Supreme Justice Court, among other artistic performers
- Parque Atlanta is a place where citizens of the United States of America and the Dominican Republic will be able to develop cultural and artistic programs to promote peace and understanding through people of all ages.







Atlanta - Tbilisi Sister City Committee

- ❖ The year 2008 constituted a turning point for the Atlanta-Tbilisi Sister City Committee (ATSCC). At the February 2008 meeting, upon the invitation of retired Brigadier General Thomas McCullough, John E. Hall, Jr. Esq. of Hall Booth Smith & Slover (HBSS) accepted the Committee's nomination to serve as the new chairman.
- Under Mr. Hall's new leadership, ATSCC began to expand and reorganize in order to meet significant challenges:
- ATSCC developed its Strategic Plan for 2008-2009 identifying its mission and setting strategic direction for long-term cooperation between Atlanta and Tbilisi;
- ATSCC expanded a network of members and friends in both countries;
- ATSCC worked with the Mayor's Office in Tbilisi, the U.S.
 Embassy in Georgia, and several international organizations to establish a counterpart committee in the Country of Georgia;
- * ATSCC nominated an Advisory Board for the Committee;
- ATSCC created a website (<u>www.atscc.org</u>) currently in its initial stages of development.

- ❖ Georgian educators visit From March 15 to 22, 2008 ATSCC hosted a delegation of Georgian educators for a visit sponsored by the Open World Program. The primary purpose of their visit was familiarization with higher education fundraising and endowment principles in the U.S. The team visited the University of Georgia, Georgia Tech, Georgia State University, Emory University, Kennesaw State University and Morehouse College. They also had the opportunity to meet Governor Sonny Perdue and The Adjutant General of Georgia, Major General Terry Nesbitt.
- ❖ Georgian lawyers visit April 26 through May 3, 2008 the ATSCC, together with the Hall, Booth, Smith & Slover, P.C. hosted a delegation of Georgian lawyers for another visit sponsored by the Open World Program. Georgian attorneys traveled to Atlanta, GA, to attend a jury-trial training program at Emory University. They were able to witness jury trials firsthand at the Fulton and Dekalb County courts. This event was part of an ongoing process to support legal reforms in the Country of Georgia.
- ❖ Humanitarian assistance awareness visit From May 10 through 17, 2008 Mrs. Letha Nesbitt, spouse of The Adjutant General of Georgia accompanied MG Nesbitt to his annual trip to Tbilisi, Georgia. As the Head of the ATSCC Humanitarian Affairs Sub-Committee, Mrs. Nesbitt visited local and international NGOs; secondary schools; infant homes and orphanages to discuss existing humanitarian relief efforts and possibilities for educational exchange programs.
- * Support rally in Olympic Park Atlanta On August 12, 2008 ATSCC showed its support to its Georgian friends by participating in the peaceful rally organized in front of the CNN Center in Atlanta in conjunction with the ongoing armed conflict between Russia and Georgia. The ATSCC wrote a petition and collected hundreds of signatures.

The Committee engaged with Counterpart International; ACTS Georgia; Atlanta United Methodist Church and other involved agencies to identify items of immediate priority for local IDPs in Georgia. US Public Health Service and Georgia National Guard provided assistance in collecting and shipping the donated items.
- ❖ A Taste of Georgian Culture fundraiser On September 27, 2008 ATSCC hosted its first annual 'A Taste of Georgian Culture' fundraiser in the atrium of Atlanta City Hall. The event turned to be a huge success, drawing over 200 guests and raising nearly \$16,000 to support the ongoing humanitarian efforts in Georgia. The fundraiser featured several special guests and samples of Georgian cuisine.
- ❖ Georgian lawyers visit From October 18 through 25, 2008 ATSCC, together with the Hall, Booth, Smith & Slover, P.C., hosted yet another delegation of Georgian lawyers for a visit sponsored by the Open World Program. This event is part of an ongoing process to support legal reforms in the Country of Georgia.

- * Meeting Mayor Ugulava In November of 2008, Mr. Hall traveled to Georgia and met Tbilisi Mayor Mr. Gigi Ugulava. Mr. Hall and Mr. Mayor exchanged gifts of good will and expressed reassurances for strengthening relationships between our two cities. Mr. Hall also met with various NGO representatives to discuss avenues for further cooperation.
