



Capital Project Update

Dekalb Avenue Safety Improvements



CURRENT ACTIVITY

Department of Watershed Management (DWM) crews have begun work on the Krog Street Stormwater Drainage-Phase I project to restore the drainage system and mitigate flooding in the Krog Street Tunnel.



LOOK AHEAD

- Krog Street Tunnel from Dekalb Avenue NE to Wylie Street SE will be closed nightly from 7 p.m. to 6 a.m., Sunday-Friday, until December 2022 to accommodate the construction at the Krog Street NE/Dekalb Avenue NE intersection.
- One sidewalk within the Krog Street Tunnel, will remain open during the project. However, some construction activity (i.e., work that requires heavy equipment to install storm pipes, etc.) will require restricted sidewalk access on both sides.
- Adjustment of manhole covers and inlets continues.
- Target completion for the Dekalb Avenue Safety Improvements project is Fall 2023.
- Krog Street Stormwater Drainage Phase I is underway, with a projected completion in Fall 2022.

- Krog Street Stormwater Drainage Phase II will begin upon completion of Phase I, with target completion date of Spring 2023.
- Resurfacing of Dekalb Avenue NE (Decatur Street SE) from Jackson Street SE to Ridgecrest Road SE (Atlanta City Limits) will follow necessary infrastructure improvements. Utility relocation work is scheduled to be completed Winter 2022.



Capital Project Update

Cascade Road/Avenue Complete Street - Phase I



CURRENT ACTIVITY

• ATLDOT crews continue clearing, erosion control, and utility relocation activities throughout the project limits.



LOOK AHEAD

- DWM began relocating water hydrants and approximately 500 linear feet of water main lines in the week of September 26. With no
 unforeseen construction challenges, DWM utility relocation will be completed on schedule.
- Three (3) more utility relocations (AGL, Bandwidth IG, and Zayo) are scheduled to begin in November 2022. Start and completion windows for additional utility relocations will be dependent on each company's relocation work. Utility companies' current projections are for completion by the end of 2023.
- Upon completion of utility relocations, sidewalk installations, pedestrian safety improvements, and signal upgrades will take place in three (3) stages:
- Cascade Road/Avenue from Delowe Drive to Avon Avenue/Cascade Circle
- Cascade Road from Tuckawanna Drive to Willis Mill Road Cascade Road from City Limits (West of Kingsdale Drive) to Tuckawanna Drive
- Resurfacing of approximately 4.25 miles of Cascade Road/Avenue from the City Limits just west of Kingsdale Drive to Ralph David
 Abernathy Boulevard will take place upon completion of all other construction activities.
- Target completion for the Cascade Road/Avenue Complete Street Phase I roadway improvements is Spring 2025.
- DWM waterline relocation is scheduled to begin the week of September 26, 2022, with projected completion in the 4th quarter of 2022

CURRENT ACTIVITY

- ROW for five of the seven parcels in the project acquired. Only two parcels remain.
- · Renewing utility agreement with Georgia Power.
- Evaluating Councilmember Norwood's request to reduce the proposed improvement footprint at the W. Wesley Rd intersection.
- Generating a cost proposal for a feasibility study to evaluate the removal of the northbound turn lane

BOOK AHEAD

- The project was advertised with two bids received. Bidders deemed unresponsive. Project will be re-bid in November.
- ROW negotiations with the remaining two parcels to be completed.
- · Legislation amendment for utility agreement in process.
- · Finalizing cost proposal for feasibility study to evaluate the removal of the northbound turn lane.

- Solicitation is being reviewed by DOL
- ROW acquisition activities ongoing for the 39 parcels on the project

- Renewed efforts to plan a Transportation Construction Vendor Expo focused on recruiting DBE firms are in progress.

Phase 0 GPC Lighting Services Audit to Support Phase 1

- Full Audit of COA's existing lighting system completed by GPC in Fall 2021
- Audit revealed that ~25% of the COA's lights were inoperable

Phase 1 GPC Acquisition and Upgrade of ~9,300 COA Lights



~85% of All Lights Scoped & Engineered



1,460 Lights Repaired (~63%)




ATLDOT LMIG Street Resurfacing 2022


