





## Cascade Road/Avenue Complete Street Phase I Eastern Limit

### **PROJECT LIMITS: Delowe Drive to Avon Avenue**

- Drainage and Erosion Improvements
- Pedestrian Safety Enhancements
- Traffic Signal and Communication Upgrades
- Shared User Amenities (Sidewalks, Bike Lanes)







## Cascade Road/Avenue Complete Street Phase I Western Limit

### **PROJECT LIMITS:** City Limits (near Kingsdale Drive) to Willis Mill Road

- Drainage and Erosion Improvements
- Pedestrian Safety Enhancements
- Traffic Signal and Communication Upgrades
- Shared User Amenities (Sidewalks, Bike Lanes)
  - Consistent lane widths (10' travel lane)
  - Center lane medians at appropriate locations
  - Dedicated and shared bike lanes
  - Sidewalks separated from travel lanes by a 2-ft buffer



• Improved Accessibility to MARTA Bus Stops

## Where We Are Today UTILITY RELOCATIONS

- 11 relocations (water, gas, telecommunications, cable, etc.) required before installation of "complete street" elements:
  - Three (3) companies Bandwidth IG, Google Fiber, and TCA have completed work
  - Three (3) companies DWM, AGL, and Georgia Power Company-Power have work in progress
  - One (1) relocation Georgia Power Company-Lighting will be completed by the contractor during the roadway work
  - Four (4) companies have not yet started the work
    - Three (3) companies AT&T, Verizon, Comcast have approved permits and will begin work when the sequencing dictate
    - One (1) company Zayo has permit application submittal pending
- Project staged to begin "complete street" installations as relocations are completed in each of the two (2) construction areas








# **Next Steps CONSTRUCTION ACTIVITIES**

- Utility relocation has started progress along the • eastern project limits – Delowe Drive to Avon Avenue.
- Eastern side "complete street" installations ullet(sidewalk installations, pedestrian safety) improvements, etc.) will begin upon completion of the eastern side utility relocations.
- Western side "complete street" installations will lacksquarebegin upon completion of the western side utility relocations.
- Resurfacing will begin once all "complete street" ulletelements are installed.











# Cascade Road/Avenue Complete Street Phase I Pedestrian Safety Enhancements Drainage and Erosion Improvements

- Concrete sidewalk, curb, gutter, and ADA ramp installation
- Pedestrian signage installation
- Signalized pedestrian crossings (rapid flashing beacons) and refuge islands
- Pedestrian <u>Safety</u> Enhancements
- Traffic Signal and Communication Upgrades
- Shared User Amenities (Sidewalks, Bike Lanes)
- Install concrete header curb and catch basins to collect and route stormwater away from roadway







## Cascade Road/Avenue Complete Street Phase I Traffic Signal and Communication Upgrades


- Improved signal timing, detection, and coordination
- Upgraded equipment (pedestrian crossing push buttons, signals, cabinets, wiring)
  - > Childress Drive
  - Lynhurst Avenue
  - Benjamin E. Mays Drive/Beecher Road
  - Boulevard Granada
  - Herring Rd/Fontaine Avenue
  - Avon Ave/Cascade Circle
  - Cascade Terrace
  - Richland Road
  - Beecher Street
  - Westwood Avenue/Donnelly Avenue





## Cascade Road/Avenue Complete Street Phase I IMPROVED MARTA ACCESS

- Improved facilities for accessing MARTA buses, including sidewalks and shelters:
  - Cascade Falls Drive
  - Childress Drive






# **Construction Impacts**

- No night work anticipated for construction activities ullet
- Temporary, single-lane closures with possible traffic delays lacksquare
- Restricted driveway access (24 to 48 hours) when sidewalk installations begin •
- **Road closures and detours** (3 proposed):

Fall 2023 - Sandtown Road to Centra Villa Drive (90 Days) Spring 2024 - Kingsdale Drive to Tuckawanna Drive (360 Days) Will take place within the same timeframe Winter 2024 - Tuckawanna Drive to Willis Mill Road (90 Days)







### Cascade Avenue/Road Complete Street Phase I

### Project Descriptions

The City of Atlanta's Departments of Transportation and Watershed Management are working to deliver corridor improvements along approximately two (2) miles of Cascade Road/Avenue. Planned improvements include milling, resurfacing, restriping, sidewalks, traffic communications corridor signal upgrades, bus stop enhancements, streetscapes, extended bike lanes, pedestrian safety improvements, and relocation of hydrants, water main lines, sidewalk meter boxes, and street valve box adjustments.

### Locations

- ⇒ Cascade Road/Avenue SW from the City Limits to Willis Mill Road SW and Delowe Drive SW to Avon Avenue SW
- ⇒ Water line relocation from Cascade Avenue SW/Clearbrook Drive SW intersection to the Cascade Road SW/Veltre Circle SW intersection

### Schedules

- ⇒ Target completion for the Cascade Road/Avenue Complete Street Phase I roadway improvements is Spring 2025.
- $\Rightarrow$  DWM waterline relocation projected for completion in the 4<sup>th</sup> quarter of 2022.

# Cascade Road Phase I and II Streetscape Project

### Other Details

- ⇒ DWM began relocating water hydrants and approximately 500 linear feet of water main lines in the week of September 26<sup>th</sup>. With no unforeseen construction challenges, DWM utility relocation will be completed on schedule.
- ⇒ There may be water service disruptions associated with the DWM relocation work. Impacted property owners will be notified (i.e., robocall, door knock, door hanger, etc.) prior to anticipated disruptions.
- Three (3) more utility relocations (AGL, Bandwidth IG, and Zayo) are scheduled to begin in November 2022. Start and completion windows for additional utility relocations will be dependent on each company's relocation work. Utility companies' current projections are for completion by the end of 2023.
- ⇒ There are no anticipated road closures associated with the water line relocation work; however, intermittent lane closures with traffic control personnel may be required to accommodate the work. Traffic advisories will be posted to the DWM and ATLDOT websites and social media platforms.
- ⇒ Upon completion of utility relocations, sidewalk installations, pedestrian safety improvements, and signal upgrades will take place in three (3) stages:
  - Cascade Road/Avenue from Delowe Drive to Avon Avenue/Cascade Circle
  - Cascade Road from Tuckawanna Drive to Willis Mill Road Cascade Road from City Limits (West of Kingsdale Drive) to Tuckawanna Drive




