A RESOLUTION BY COMMITTEE ON COUNCIL

A RESOLUTION AMENDING AND RESTATING RESOLUTION 17-R-4089 TO INCREASE THE NUMBER OF ADVISORY COMMITTEE MEMBERS AND TO PROVIDE FOR STAFFING FOR THE ADVISORY COMMITTEE CREATED TO REVIEW ALL CITY OF ATLANTA ("CITY") STREET NAMES AND MONUMENTS ASSOCIATED WITH THE CONFEDERACY AND TO RECOMMEND A PROCESS TO DETERMINE THE FUTURE OF SUCH STREETS AND MONUMENTS; AND FOR OTHER PURPOSES.

WHEREAS, the recent tragic events in Charlottesville, Virginia have brought renewed attention to monuments and street names around the country, with many elected officials, clergy and members of the public calling for their removal; and

WHEREAS, the City of Atlanta ("City") is known across the country and world for being a beacon of equality, diversity and inclusion; and

WHEREAS, the City believes that it is important to review all City street names and monuments associated with the Confederacy in a thoughtful and intentional manner; and

WHEREAS, pursuant to Resolution 17-R-4089, the City created an advisory committee (i) to review City street names and monuments associated with the Confederacy and (ii) to develop a process and provide recommendations to determine the future of such street names and monuments; and

WHEREAS, the establishment of the advisory committee ensures that the City reviews requests regarding City street names and monuments associated with the Confederacy in a thoughtful manner; and

WHEREAS, the City desires to amend and restate Resolution 17-R-4089 to increase the number of advisory committee members to provide for greater input on this important issue and to provide City department staffing for the advisory committee.

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY RESOLVES, that Resolution 17-R-4089, which created an advisory committee (i) to review City street names and monuments associated with the Confederacy and (ii) to develop a process to lead and engage the residents of the City in meaningful conversations and provide recommendations to determine the future of such street names and monuments is hereby amended and restated to increase the number of advisory committee members to eleven (11) members.

BE IT FURTHER RESOLVED, that the Mayor shall submit a letter to the Municipal Clerk recommending six (6) members to the advisory committee, and the Atlanta City Council President shall submit a letter to the Municipal Clerk recommending five (5) members to the advisory committee. City Council confirmation is not required for advisory committee members.

BE IT FURTHER RESOLVED, that the advisory committee shall operate under the purview of the Mayor's Office and shall be staffed by the Executive Director of the Urban Design Commission.

BE IT FURTHER RESOLVED, that the meeting schedule of the advisory committee shall be established at the first meeting of the committee. The advisory committee may hold public hearings if it so deems necessary or desirable.

BE IT FINALLY RESOLVED, that the advisory committee shall deliver a comprehensive written report with its recommendations to the Mayor and City Council no later than seventy (70) days from the adoption of this Resolution and the advisory committee shall terminate upon delivery of the report.
