AN ADMINISTRATIVE ORDER**

AN ADMINISTRATIVE ORDER DIRECTING THE CHIEF OPERATING OFFICER TO COORDINATE WITH THE CHIEF OF THE ATLANTA POLICE DEPARTMENT TO DISSEMINATE DIRECTION THROUGHOUT THE ATLANTA POLICE DEPARTMENT THAT MEMBERS THEREOF SHALL REFRAIN FROM TAKING ANY ACTION TO ENFORCE ANY PROHIBITIONS AGAINST THE SALE OF UNOPENED WINE AND/OR MALT BEVERAGES BY THE PACKAGE FOR OFF PREMISES CONSUMPTION BY RESTAURANTS AND OTHER EATING AND DRINKING ESTABLISHMENTS LICENSED FOR CONSUMPTION OF WINE AND/OR MALT BEVERAGES, UNTIL SUCH DATE AS CITY HALL AND OTHER CITY FACILITIES SHALL REOPEN TO THE PUBLIC.

WHEREAS, like much of the world the United States, the State of Georgia, and the City of Atlanta are currently responding to an outbreak of respiratory disease caused by a novel coronavirus named “SARS-CoV-2” and the disease it causes named “coronavirus disease 2019” (abbreviated “COVID-19”); and

WHEREAS, on March 11, 2020 the World Health Organization declared the COVID-19 outbreak a pandemic; and

WHEREAS, on March 13, 2020 the President of the United States announced a national emergency in response to the COVID-19 pandemic, which included two emergency declarations: one under the National Emergencies Act and one under the Stafford Disaster Relief and Emergency Assistance Act; and

WHEREAS, on March 14, 2020 Governor Brian Kemp signed a public health state of emergency to address the COVID-19 pandemic through assisting health and emergency management officials across Georgia by deploying all available resources for the mitigation and treatment of COVID-19; and

WHEREAS, due to the COVID-19 pandemic, on March 15, I declared there to be an emergency in existence within the City of Atlanta pursuant to Section 2-181(a) of the City of Atlanta Code of Ordinances and closed City Hall and other City Facilities to the public; and

WHEREAS, the Center for Disease Control (“CDC”) has issued guidance on the emerging and rapidly evolving situation of the COVID-19 pandemic, including how to protect oneself from this illness; and

WHEREAS, social distancing was recommended by the CDC to prevent the continued spreading of this illness in the community; and

WHEREAS, on March 22, 2020 twenty-four (24) infectious disease clinicians in Georgia signed onto an opinion that it is in their belief that there is little time to “flatten the curve” of the spread of COVID-19; and

WHEREAS, on March 23, 2020 I declared there to be the existence of an emergency within the City of Atlanta and issued a Stay at Home Order under my emergency powers and which I have reissued in accordance with Section 2-181 of the City of Atlanta Code of Ordinances no more than every 72 hours thereafter; and

WHEREAS, on April 2, 2020, Governor Brian Kemp signed an Executive Order to Ensure a Safe and Healthy Georgia (Governor's Executive Order 04.02.20.01) to address the COVID-19 pandemic by implementing temporary actions necessary and appropriate to protect the health, safety, and welfare of Georgia's residents and visitors, effective beginning at 6:00 P.M. on Friday, April 3, 2020 and expiring at 11:59 P.M. on Monday, April 13, 2020; and

WHEREAS, on April 8, 2020 Governor Kemp signed an Executive Order 04.08.20.02 extending the Governor's Executive Order 04.02.20.01, such that it expired on Thursday April 30, 2020 at 11:59 P.M.; and

WHEREAS, on April 23, 2020 Governor Kemp signed an Executive Order 04.23.20.02 which, effective May 1, 2020, lifted the shelter in place order for most residents and visitors of the State of Georgia, including the City of Atlanta, leaving it in place only for persons who are considered at higher risk for severe illness resulting from a COVID-19 infection, and requiring businesses to operate pursuant to certain COVID-19 mitigation operational measures; and

WHEREAS, the Governor's Executive Order 04.23.20.02 is scheduled to remain effective through May 13, 2020; and

WHEREAS, to help mitigate the negative impacts on those business entities and individuals which may experience negative impacts on revenue and incomes as a result of the COVID-19 pandemic, and the emergency actions necessary as a result thereof, on March 20, 2020 I issued Administrative Order 2020-07, via which I directed the Chief Operating Officer to coordinate with the Chief of the Atlanta Police Department to disseminate direction throughout the Atlanta Police Department that members thereof shall refrain from taking any action to enforce any prohibitions against the sale of unopened wine and/or malt beverages by the package for off premises consumption by restaurants and other eating and drinking establishments licensed for consumption of wine and/or malt beverages which must cease offering dine-in services, but which may continue to prepare and offer food to customers via delivery service, drive-through, or take-out in accordance with any emergency declaration made in response to the COVID-19 pandemic, for a period not to exceed sixty (60) days; and

WHEREAS, Administrative Order 2020-07 is scheduled to expire on May 19, 2020; and

WHEREAS, despite the fact that restaurants are currently able to offer dine-in service pursuant to the Governor's Executive Order 04.23.20.02, in the opinion of leading medical and scientific experts, it remains unsafe to cease social distancing measures; and

WHEREAS, because it remains unsafe to cease social distancing measures, it remains unsafe for City of Atlanta employees and other members of the public to congregate in City Hall or other City Facilities; and

WHEREAS, therefore, I have continued to order that City Hall and other City Facilities shall remain closed to the public; and

WHEREAS, so long as the advice of medical and scientific experts results in the need to keep City Hall and other City Facilities closed to the public, I wish to continue measures which have been implemented to encourage businesses and individuals to continue to socially distance themselves throughout the territorial limits of the City; and


WHEREAS, accordingly, to help mitigate the negative impacts on those business entities and individuals which may experience negative impacts on revenue and incomes as a result of their desire to act in a

responsible manner by remaining closed for dine-in services based on the advice of medical and scientific experts, I am hereby directing the Chief Operating Officer to coordinate with the Chief of the Atlanta Police Department to disseminate direction throughout the Atlanta Police Department that members thereof shall refrain from taking any action to enforce any prohibitions against the sale of unopened wine and/or malt beverages by the package for off premises consumption by restaurants and other eating and drinking establishments licensed for consumption of wine and/or malt beverages, until such date as City Hall and other City Facilities shall reopen to the public.

NOW, THEREFORE, BY THE POWER VESTED IN ME AS MAYOR OF THE CITY OF ATLANTA, pursuant to Section 3-104 of the City of Atlanta Charter and Section 2-182(4) of the City of Atlanta Code of Ordinances, it is hereby ordered:


That the Chief Operating Officer shall coordinate with the Chief of the Atlanta Police Department to disseminate direction throughout the Atlanta Police Department that members thereof shall refrain from taking any action to enforce any prohibitions against the sale of unopened wine and/or malt beverages by the package for off premises consumption by restaurants and other eating and drinking establishments licensed for consumption of wine and/or malt beverages, from the date of execution of this order, until such date as City Hall and other City Facilities shall reopen to the public.
