## **VIOLATIONS**

City of Atlanta Municipal Code of Ordinance 114-528 (b) (3) Failure to carry out an official directive or refusal to carry out the lawful, reasonable directions given by a supervisor or other acts of insubordination.

## FINDINGS OF FACT

- 1. The Appellant on December 17, 2017 was a Process Control Technician employee of the City of Atlanta Department of Watershed Management (DWM), Office of Water Treatment and Reclamation (OWTR).
- 2. On December 1, 2017, Mr. Lubin left his assigned work area without obtaining his supervisor's permission.
- 3. Mr. Lubin was charged with being in violation of City Code 114-528 and received a five-day unpaid suspension effective Feb. 5, 2018.

#### **DISCUSSION**

Several things became apparent to the Board during testimony of the witnesses and the Appellant. The work responsibilities of Mr. Lubin and his Supervisor Kelvin Duffy are extremely important to the City's water supply, safety, and drinkability. It was also apparent that the relationship between the two was quite strained, as was indicated by previous incidents of similar nature between Lubin and Supervisor Duffy. It was clearly presented that Mr. Lubin on several occasions left his assigned plant without permission or notification to his Supervisor, as is prescribed and required in a Department Memorandum, of which Mr. Lubin was well aware.

However, it was presented that Mr. Lubin's expertise was often needed and requested at other City Water Treatment Plants, and his testimony was that he was responding to urgent and sometimes emergency requests. The City did not present any evidence or arguments that disputed his presence and assistance at other City Water facilities. Also, Mr. Lubin testified that informing his Supervisor via phone or email was difficult in many of the Plants because of being either underground or surrounded by water which impeded signals. Moreover, contacting a supervisor during the early morning hours of the third shift was inconsiderate and inappropriate.

The Board recognizes the insubordination of the Appellant in this incident, but also heard nothing that contradicted his testimony that his leaving one City facility was to answer requests from other City facilities for his special expertise. We surmise that better communications between Facilities may have been needed as well.

#### **ORDER**

Accordingly, the Board **Modifies** the discipline of a **Five (5) Day Suspension** imposed by the City against the Appellant to a **Three (3) Day Suspension** as permitted by Code.
