HELPFUL DEFINITIONS:

Applications submitted = Total number of projects reviewed by the Arborist. Not all projects requested tree removals and were statused as Approved-No Trees Destroyed.

DBH = Diameter at Breast Height is the standard measure for the size of a tree.

DBH unknown = the count of trees where removal has occurred and there is no ability to determine the diameter of tree removed, i.e., cut down to the stump or grinded.

Infrastructure = Permits for tree removal when installing infrastructure (utilities, etc.) on a property

Landscape = Permits for tree removal where no other planned construction on the property is occurring.

Plan Review = Approvals for tree removal when associated with planned construction and development of a property, including all commercial, multi-family, and residential project scopes.

Sites Inspected = Total number of sites requesting a DDH inspection

TCI = Total Caliper Inches is the standard measure for the size of a tree that was replanted
