WHEREAS, the Development Impact Fee Advisory Committee was established pursuant to Ordinance 18-O-1764; and

WHEREAS, the Committee is comprised of five voting members, two appointed by the Mayor and three appointed by the Atlanta City Council; and

WHEREAS, at least three of the members of the Committee shall be representatives of the development, building, or real estate industries; and

WHEREAS, Councilmember Andrea L. Boone, Committee on Council Chair, requested that names of nominees for the three Council appointments to be submitted by 5:00 pm on Thursday, June 23 (attached as Exhibit A); and

WHEREAS, the following three names were submitted by the deadline: Mitchel Shelby, Zach Gober, and Malloy Peterson; and

WHEREAS, Ms. Peterson is the Senior Vice President of Selig Development and meets the requirements to serve on this Committee; and

WHEREAS, the Atlanta City Council recommends that Malloy Peterson be appointed to the City of Atlanta Development Impact Fee Advisory Committee.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that Malloy Peterson is hereby re-appointed to the City of Atlanta Development Impact Fee Advisory Committee as one of the three members appointed by the Atlanta City Council. This appointment is for a term of two (2) years, said term to begin upon the approval of this resolution.
