


STEP-BY-STEP PROCESS TO RENEW SHORT-TERM RENTAL LICENSE


Step 1: Click on the Link below to reach the City of Planning website.


Step 2: Login into your account by clicking on the Login button shown in the screenshot.




Step 3: Enter Username and Password and click login.
