Good afternoon,

The Office of the Inspector General (OIG) obtained these devices in connection with ongoing investigations. Under the Charter. OIG has a right to these devices and the City records they contain.

As noted during my conversation yesterday with CIO Sankey, OIG endeavors to perform its Charter mandate in a manner that minimizes, as much as possible, any negative impact on City operations. To the extent that there are tracking and accountability concerns about the devices recently obtained by OIG, I am happy to complete any documentation or take steps to confirm that these items are in OIG's possession. Indeed, I sought a follow-up call with CIO Sankey so that I might explore ways to do just that. And to address such issues going forward, CIO Sankey and I discussed potential revisions to City policy to incorporate OIG activity. In much the same way I see OIG as working collaboratively and complementarily with City departments to advance the shared goals of City operations conducted with integrity, I believe that with fairly minor tweaks to the policy, we can help ensure that the future needs and concerns of OIG and AIM are satisfied.
